MENTAL HEALTH AND LONG-TERM CARE

On December 21st, 2019
MPP Sabawy announced a new investment to end hallway healthcare and focuses on Mental Health.

"Ontario's Government is committed to ensuring that each dollar goes directly to services that will make a significant difference to patients," said Sheref Sabawy MPP for Mississauga – Erin Mills·
"This immediate investment will help lower wait times for those in need of inpatient mental health and addictions treatment·"



As part of the first wave of direct mental health and addictions investment, Trillium Health Partners, Credit Valley Hospital is receiving funding for

Ontario's Government is investing in urgently needed mental health and addiction services in Mississauga and engaging with health care leaders, front line staff and people with lived experiences to address the critical gaps in the province's mental health care system.

PROJECT NOW



\$3 Million in 3 Years

Ontario Government is investing \$3 million over three years in a new mental health initiative called Project Now, which aims to end child and youth suicide in Mississauga within the next decade by 2029.

To date, the project has also received over \$3 million in support from donors in the community.

Project Now is a cross-sector partnership that will improve access to mental health services in schools, hospitals and community-based agencies. This funding will support suicide prevention and mental health initiatives led by core partners, including Trillium Health Partners, the Region of Peel, Peel District School Board, Dufferin-Peel Catholic District School Board, Peel Public Health and Peel Children's Centre.

As the government is investing \$72 million more this year in long-term care homes, they are working with the sector partners to help ensure that they can achieve the maximum value of this funding. That means looking at ways to offer homes more funding flexibility to priority areas and responsibly reducing red tape regulations.

The government is committed to helping long-term care providers be more responsive to the needs of their residents, while also maintaining safety and high quality of care.

They are investing \$1.75 billion over the next five years to build 15,000 new long-term care beds and renovate an additional 15.000 beds.

INFRASTRUCTRE FOR HEALTHCARE



\$3.3 Million Dollars in Mississauga – Erin Mills

Ontario is investing in the health and safety of patients as it addresses urgent upgrades, repairs and maintenance to help modernize Credit Valley Hospital. This is part of the \$4.6 Million dollars announced to Trillium Health Partners for Mississauga.

SENIORS DENTAL CARE

Widening of Hwy 401

Ontario Government is making life easier for drivers by widening 18 kilometers of Highway 401 from Mississauga to Milton. From Credit River in Mississauga to Regional Road 25 in Milton so that thousands of Ontarians will spend less time in traffic and more time with their loved ones.

Commitment to build the Hurontario LRT Line

Mississauga-Erin Mills — Ontario is creating a climate that will support and attract business investment and job creation in Mississauga-Erin Mills by proposing to reduce the small business tax rate and eliminate unnecessary or outdated regulations.

SAVING BUSINESSES \$2.3 Billion DOLLARS

"Mississauga is a city of tremendous opportunity and potential however, high taxes and burdensome red tape have been driving investment and jobs away," said MPP Sheref Sabawy. "That is why the government is creating the conditions for success by reducing taxes and eliminating outdated and duplicative



The Government reduced the **Small Business Corporate Income Tax rate to 3.2%** starting January 1, 2020. This would provide tax relief of up to \$1,500 annually to over 275,000 businesses from family-owned shops to innovative start-ups.

Ontario is also reducing red tape to support businesses by eliminating over 80 actions to unnecessary or outdated rules

Red tape—burdensome, outdated, and duplicative regulations—has cost Ontario jobs, hindered the competitiveness, held back wage increases and cost opportunities for families and businesses to get ahead.

The Government is working to make things easier by removing regulatory overlap and developing regulations that are focused and streamlined — while maintaining standards to keep Ontario workers and families safe and healthy, and to protect the environment. Our families expect and deserve clean air and clean water. They deserve safe products. They deserve safe working conditions. Effective regulations are there to ensure and protect these things.

REDUCING RED TAPE The Government regulatory vision is one in which people are better served by local & provincial government; businesses are unshackled to do what they do best — create jobs and grow wages; and municipalities are free to build and invest in their communities and deliver efficient, effective services to their residents.

MAKING ONTARIO WORK BETTER FOR YOU

Reducing Ontario's regulatory burden is not just about helping people at work, it's also about helping them in their everyday life by freeing them to make choices that suit them.



Freezing Workplace Safety and Insurance Board rates for not-for-profits

Ontario's not-for-profit organizations, like food banks, daycares and soup kitchens, do so much for our communities across the province,

so we must ensure removing barriers that prevent them from helping those in need. That's why the government announced a freeze on WSIB rate increases for not-for-profit organizations, enabling them to focus their resources on the great work that they do.



INCREASING THE SCOPE OF PHARMACISTS

Ontario's pharmacists are highly skilled. In April 2019, to help free up doctors and nurse practitioners to care for more complex patient needs and to save families time in multiple waiting rooms, the government committed to expanding the scope of pharmacists to treat minor ailments by prescribing and administering certain drugs and renewing certain prescriptions for up to one year.

That way, people can get the help they seek immediately.

<u>Preparing students for the future</u>

Ontario is making changes to strengthen its publicly funded education to better prepare students with the skills, knowledge and confidence they need to succeed in the future, whatever path they choose.

The objective is to work with the education partners to improve teacher mobility, while increasing transparency, fairness, consistency and accountability in teacher hiring across all school boards BASED ON MERIT

The Government is working with the Education Quality and Accountability Office (EQAO) to modernize the agency and its processes, while using data to build better assessment and evaluation models that have a greater focus on equity.

Health and Physical Education curriculum

The 2019 Health and Physical Education (HPE) curriculum for Grades 1-8 is informed by the results of the consultation, as well as research and learnings from other jurisdictions. The result is a modernized and inclusive curriculum that helps students learn the skills and knowledge they need to lead healthy, active lives and make healthy and safe choices.

This learning relates to the everyday experiences of students – at home, at school and in the community – and helps students develop skills and habits that will enhance their physical, social-emotional and mental well-being for the rest of their lives. For Grades 1–8, Ontario's updated HPE curriculum now includes:

- Mandatory learning about mental health, including a new section on socialemotional learning skills
- New learning about concussions
- New and updated learning about body image, consent and online safety
- Age-appropriate sexual health education

The Government Invested Over \$20 Million to Strengthen Community Safety in Peel.



Part of the funding will go towards Peel Regional Police's Community Mobilization Program. This initiative assigns police officers to small teams that work directly with members of the community on projects to improve public safety including neighborhood watches, town hall meetings, and cultural community outreach. This initiative is part of the \$195 million total investment the province is making over the next three years through the province's new Community Safety and Policing (CSP) Grant program.
